Rhythm™ is a high-quality range of electronic, portable infusion pumps, administration sets and related accessories, for use in both hospital and homecare applications. The pumps are Class11b re-usable medical devices for the continuous, and/or bolus administration of a wide range of therapeutic medicines, including post-operative pain management, obstetrics, antibiotic therapy, oncology and immunoglobulin infusions. https://micrelmed.com

Subject to marketing approval from the Therapeutic Goods Administration (Australia) and Medsafe (New Zealand), the company expects to launch this product range in FY24. The Rhythm™ pumps form a key part of the company's strategy to replace the ambIT® product range, which is scheduled for discontinuation in Australia and New Zealand in mid-2024.

Dr Richard Treagus, Executive Chairman commented, "With our strong market position in acute pain management, we are executing on our strategy to replace and expand our infusion product offering to hospitals.
